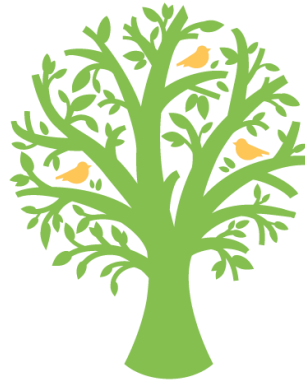

## **PHILOSOPHY**

A program dedicated to training Montessori teachers must have as its guiding values the fundamental principles upon which Maria Montessori based her philosophy. The same principles that pertain to children's education need to be applied, whenever possible, to adults. CMSTE demonstrates that if this same philosophy is upheld, adult learners taking the training will develop a love of the Montessori philosophy and methodology that will continue long past the completion of their Teacher Education Program.

### **The CMSTE Philosophy, therefore, includes the following principles:**

- In following Montessori's concern for the adult learner's freedom of choice, CMSTE is guided by a deep respect for each adult learner's individual process of development. Examples of methods used to encourage the adult learner's freedom of choice are: open-ended discussion, questions in Independent Study, and individually selected research projects.
- Because Montessori emphasizes the active participation of the learner, this teacher education program focuses in on the activity of the adult learner. Class participation, written assignments, illustrated lesson albums, and practical final evaluations are methods by which CMSTE provides opportunities for active adult learner participation.
- Montessori felt that the process of development was much more important than the end product. Therefore, CMSTE attempts to provide an atmosphere of positive cooperation among all individuals in the program. Closely supervised self-evaluations, constructive guidance, and an emphasis on objective evaluation are some of the methods used to implement this belief and to assist in your spiritual development as a Montessori teacher.

### **Objectives of the Teacher Education Program**

- The adult learner will be able to demonstrate knowledge of Montessori philosophy, theory, and methodology.

- The adult learner will be able to demonstrate theoretical knowledge of pertinent research findings in the field of child development and early childhood education.
  - The adult learner will be able to demonstrate practical ability in implementing the Montessori materials.
  - The adult learner will have the insights and skills needed to work with the individual needs of children and plan for the continuity of learning experiences for children age 2 ½ through 6.
  - The adult learner will become part of a “team” in a school and will learn how to work with co-workers and with administration of the school.
  - The adult learner will demonstrate love for children and for the Montessori method.
  - The adult learner will be able to discuss human development and Montessori concepts to other staff, parents, and the community.
  - The adult learner will meet MACTE competencies related to:
    - Montessori Philosophy and Human Development
    - Classroom Leadership
    - Curriculum Implementation
    - Community Involvement and Partnership with Families

## **Course Cycle**

CMSTE accepts adult learners who hold a high school degree, bachelor’s degree, or international degree. This course may be completed in one or two academic years. Each year the course begins in September and ends in June.

Adult learners begin the Independent Study component (Section I) at any time. Seminar Instruction (Section II), meets from September to June. The Practicum (Section 3) may begin either concurrently or after Section II. Adult learners may take Independent Study (Section I) and Seminar Instruction (Section II) for one course cycle and complete the Practicum (Section III) the following academic year. One course cycle is one academic year.

---

Adult learners have three years to complete all requirements for the course. Adult learners who request an extension after three years, are subject to an extension fee, as described in the tuition section. Extension may only be granted by the Director of the course. All extension requests must be made in writing.

*Continuation Policy: Adult learners who choose to leave the course may return to complete the course within two years. There is a continuation fee of \$500 per year.*

## **Montessori Early Childhood Education Credential**

Upon satisfactory completion of all objectives of the teacher education program, course work, practicum, and assignments, the Director will recommend qualified adult learners be awarded a credential for Montessori Early Childhood Education through the American Montessori Society. The adult learner is then qualified to apply for a position as a Montessori teacher. If the adult learner does not complete all of the above objectives, the Director will recommend a second year of practicum for the adult learner.

Upon successful completion of all requirements, and the recommendation of the Director, adult learners holding a bachelors degree, the equivalent, or higher are recommended for an AMS Montessori Early Childhood Teaching Credential (ages 2 ½ through 6).

Upon successful completion of all requirements, and the recommendation of the Director, adult learners without a bachelors degree will be recommended for an AMS Montessori Associate Early Childhood Teaching Credential (ages 2 ½ through 6).

Upon completion of the course, if the adult learner does not hold a U.S. Bachelors Degree or the equivalent, they will receive a Montessori Associate Early Childhood Teaching Credential. Some locations or schools may not accept the Montessori Associate Early Childhood Teaching Credential as qualification for full teaching responsibility.

#### Section I: Independent Study – Online 140 Hours

##### Introduction

The Independent Study consists of carefully sequenced lessons in Montessori philosophy and child development. This course provides the theoretical foundation needed to successfully implement Montessori principles in the classroom. Independent Study includes online study.

There are three sections to the Independent Study.

Part 1: Principles and Philosophy of Montessori Education

Part 2: Human Development

Part 3: Classroom Observation

### Part 1: Montessori Philosophy

Adult learners use required texts, a study guide, and online information for guided studies on ten lessons including an overview of Dr. Montessori's life and the development of the Montessori Method. Adult learners will write a paper on Montessori's life and the development of the Montessori Method. Adult learners will write and present a paper on Montessori philosophy or human development.

### Part 2: Human Development

Human development consists of guided reading and videos on the developmental patterns of young children from ages 2 ½ through 6. The emotional, social, physical, spiritual, and intellectual development of children will be studied. Adult learners will write a paper on child development.

### Part 3: Classroom Observations

The adult learner observes six different Early Childhood Montessori classrooms and writes observation documentation. Seminar instruction provides strategies for scientific observation of children through overview and record keeping, lecture, video, discussion, guided practice and field observation. Interns observe, record, and discuss development of 3 different children.

## **Section II: Seminar Instruction— In Residence 160 Hours**

### **Human Development/Psychology**

Various theories of human development are reviewed and compared with Maria Montessori's philosophy. Adult learners study the developmental stages of children and the factors influencing a child's development and learning. Past and present theories of human development are studied.

### **Montessori Philosophy/Theory**

Montessori principles and philosophy are discussed in detail and practical exercises of basic Montessori terminology are given. Adult learners will learn how the Montessori philosophy is the basis for the teacher's and child's classroom experiences.

### **Observation**

Seminar instruction provides strategies for scientific observation of children through overview and record keeping, lecture, video, discussion, guided practice, reflection, and field observation.

## **Practical Life**

Introduction to the Practical Life theory and presentation of materials. Adult learners participate in demonstrations, supervised practice, and the design of original materials. Adult learner progress is assessed through written and practical assignments.

## **Sensorial**

Sensorial theory is discussed, lectures and demonstrations of the Montessori Sensorial materials are given. Adult learners participate in demonstrations, supervised practice and review, and the design of original materials. Adult learner progress is assessed through written and practical assignments.

## **Mathematics**

Mathematics curriculum includes seminars on the child's development of logical thinking skills and refinement of the mathematical mind. A progression of materials is demonstrated from pre-math, to early math materials used in the Montessori classroom, to the four formal and informal operations. Adult learners develop a mathematics album, and participate in supervised practice, review, and assessment. Adult learner progress is assessed through written and practical assignments.

## **Language**

The purpose and progression of the Montessori Language sequence is given. The language curriculum includes seminars on the acquisition of language and reading skills, from pre-reading skills through grammar. Adult learners are given a specific, complete reading program and many extras in this course. Adult learner assignments include material-making, completion of a Language Album, supervised practice, and adult learner assessment. Adult learner progress is assessed through written and practical assignments.

## **Art**

Adult learners will study a progression of basic art skills, including use of the easel, snipping, painting and sculpting. The rationale for presenting art and basic scribbles will be discussed.

## **Movement**

This course offers adult learners a rationale for Perceptual Motor activities for young children, body awareness activities, an overview of basic perceptual motor skills and their importance to brain development and learning, and line activities.

## **Music**

This course includes the philosophy and rationale for teaching music to young children. Adult learners will practice new songs, singing and rhythm skills, use of

the Montessori Bells and rhythm instruments. An introduction to music history and appreciation will also be presented.

### **Geography Studies**

Geography studies provide an avenue towards Peace Education. Adult learners will study Montessori Geography and Social, Physical and Political Geography. Maps, land and water forms, three-part cards, people, animals, continents and flag studies will be integrated into Geography studies.

### **Science**

The Science curriculum includes Botany and Zoology studies and Physical Science experiments which explore scientific principles of states of matter, properties of solids, liquids and gases, energy, and magnetism. Earth Science integrates history in studies of the Big Bang Theory, the Sun and Planets, Geology, and the formation of life on Earth.

### **Social Studies**

When studying the concept of history, the young child learns about the passage of time, day and night, and the seasons. The adult learner will work with materials related to telling time, the seasons, various types of calendars, and a child's personal timeline. They will study Art History with an overview of schools of art and a series of art cards.

### **Parent Educator Partnership**

Adult learners will examine strategies to increase parent understanding of and involvement in the Montessori method of education, brainstorm ways to increase parent participation, practice oral and written communication skills with parents, and participate in a variety of school events such as parent night and conferencing.

### **Classroom Leadership**

Classroom Leadership studies include preparation of environment, strategies for lesson presentation, curriculum scheduling and planning, positive techniques for communication, discipline, and problem-solving, and evaluation of children.

## **Section III: Practicum – One Academic Year**

---

The practicum provides adult learners with a supervised teaching/learning experience and an opportunity to integrate the Montessori theory and practice. Adult learner practicum consists of a minimum of 540 hours over 9 months, 4 hours **a day** Monday through Friday in an approved Montessori classroom with children under the guidance of a Supervising Teacher.

Adult learners may begin the practicum after completion of 6.5 hours of seminar instruction, and all independent study reading assignments, and all required written work, and fees are turned in. The adult learner is responsible for quarterly documented observations and reports, year-long observations, and developing a year-long research study, which shall be demonstrated during the 2 week Lead teaching experience.

Adult learners desiring a self-guided practicum must receive written approval from the Course Director. The Practicum Site must meet all requirements for internships. The Field Supervisor will provide extra support with one extra site visit and in-person consultation at the CMSTE office once each month during the Practicum period. Adult learner tuition will increase by \$500 for the above services.

Fulfillment of practicum requirements will be determined by the Director of CMSTE, based on observations, documentation, year-long research study grade, satisfactory completion of the objectives of the teacher education program, and lead teaching. Upon the successful completion of the Independent Study, Seminar Instruction, and Practicum phases, adult learners who are ready to be a Lead Teacher in the classroom will receive a recommendation to receive an AMS teaching credential.

## **PRE-ADMISSION EVALUATION**

- Adult learner's ability to clearly read and write competently in English.

- Two years of college experience or previous positive employment experience with children is recommended.
  - For the purposes of determining each adult learner's ability to succeed from the program, Chestnut Montessori School Teacher Education requires a written essay on "Why I Want to Become a Montessori Professional and Why I Have Chosen Chestnut Montessori School Teacher Education," submitted by email to [info@montessoriteachereducation.org](mailto:info@montessoriteachereducation.org).
  - Two letters of reference sent by email to [info@montessoriteachereducation.org](mailto:info@montessoriteachereducation.org).
  - Official school transcripts or an official school transcript evaluation must be sent as an e-transcript or pdf to [info@montessoriteachereducation.org](mailto:info@montessoriteachereducation.org).
  - The Director, Jeannine Hanson, will also meet with each adult learner to determine his or her motivation and willingness to complete the course.

## ENROLLMENT PROCEDURES

The admission process is available year-round. Adult learners may begin the Independent Study during the first week of August. However, adult learners may begin the academic workshops only in September. Adult learners wishing to apply for training complete the following:

1. An initial phone meeting with the administration to discuss course specifics.
2. Completion of the Application for Admission form online with the stated non-refundable fee. Instructions for application and payment are online.
3. Provide two letters of reference sent by email to [info@montessoriteachereducation.org](mailto:info@montessoriteachereducation.org).
4. A written essay (250-300 words) by the adult learner on "Why I Want to Become a Montessori Professional and Why I Have Chosen Chestnut Montessori School Teacher Education." The essay must be submitted by email to [info@montessoriteachereducation.org](mailto:info@montessoriteachereducation.org).
5. Submission of official high school or college e-transcripts directly from the school or university. If the transcript originated outside of the United States, an original transcript evaluation is required. E-transcripts must be sent from the school or service directly to CMSTE at [info@montessoriteachereducation.org](mailto:info@montessoriteachereducation.org).

A transcript from a non-U.S. regionally accredited college/university must be submitted to a recognized U.S. credentialing agency (e.g. a credentialing agency that is a member of NACES – the National Association of Credential Evaluation Services) for credit equivalency evaluation. Accredited colleges and universities in the United States may also make such evaluations. If the evaluation determines the non-U.S. transcript to be equivalent to a bachelor's degree or higher in the U.S., the adult learner will satisfy the bachelor's degree requirement for an AMS credential upon successful completion.

6. Completion of 2 years of college or equivalent is recommended.
7. The adult learner will be notified of acceptance in writing.
8. Adult learner must sign an "Enrollment Agreement" and pay "Tuition Deposit Payment" before receiving the Adult Learner Handbook.

9. Meet state requirements for completion of Background Check.

## **AMS EARLY CHILDHOOD MONTESSORI TEACHING CREDENTIAL**

Upon successful completion of all requirements, and the recommendation of the Director, adult learners holding a bachelors degree, the equivalent, or higher are recommended for an AMS Montessori Early Childhood Teaching Credential (ages 2 ½ through 6).

Upon successful completion of all requirements, and the recommendation of the Director, adult learners without a bachelors degree will be recommended for an AMS Montessori Associate Early Childhood Teaching Credential (ages 2 ½ through 6).

Upon completion of the course, if the adult learner does not hold a U.S. Bachelors Degree or the equivalent, they will receive a Montessori Associate Early Childhood Teaching Credential. Some locations or schools may not accept the Montessori Associate Early Childhood Teaching Credential as qualification for full teaching responsibility.

## **PROFESSIONAL DEVELOPMENT REQUIREMENTS**

AMS requires that holders of AMS credentials issued on or after July 1, 2013 complete 50 hours of professional development every 5 years for the credential to remain active. The first 5-year period begins with the date the credential was issued. If professional development hours are not completed within the 5-year period, the credential will be considered inactive until the requirement is met.

The credential holder must keep a record of his or her professional development and be able to provide, upon AMS request, print or electronic verification of the event host, location, date, topic, presenter(s), and number of hours attended. For this purpose, the credential holder is welcome, but not required, to use the AMS Professional Development Form.

To maintain an active credential, verification of professional development is to be submitted to AMS 30 days in advance of the 5-year anniversary of the issuance of the credential, and every 5 years thereafter (no forms should be submitted prior to June 2018).

All Washington State credentialed teachers are required to complete 10 STARS hours annually.

## **INTERNATIONAL STUDENTS**

While CMSTE does not provide visas for international students, those in good legal status are welcome to apply for the course.

## **SCHOOL CALENDAR**

Our adult learner-faculty contact hours take place on Tuesday and Thursday from 3:45 PM until 7:45 PM. Adult Learners may arrive between 3:30 and 3:45. Please do not eat or drink in the classroom, with the exception of water. Adult learners must remain on campus during class time.

Independent Study: Begins upon completion of Admissions Process.

Seminar Instruction: Consists of 152 hours in-residence and 148 hours online. Class meets for 8 hours per week on Tuesday and Thursday from 3:45-7:45pm through the first week of June. Most in-residence classes are held on Tuesdays and online classes on Thursdays. All legal holidays are observed.

Practicum: Practicum begins when 8 hours of Seminar Instruction are completed. The Intern is required to work in an approved Early Childhood Classroom with children Monday through Friday for minimum of 540 hours, 4 hours a day for one academic year. It is required that interns participate in responsibilities that directly relate to being a Montessori Teacher, such as Parent Teacher Conferences and Parent events.

This course can be completed in 1 academic year if adult learners complete all requirements.

Adult Learners do have an option to complete the course over 2 academic years without incurring any additional tuition, MACTE or AMS fee. This option



---

requires attendance in the Seminar instruction the first year and the Practicum the second year. Independent Study requirements must be completed during the adult learner's first year of study.

## **FINANCIAL ASSISTANCE**

## **FACILITIES**

## **CLASS SIZE**

Class size is limited to 24 beginning adult learners. The Adult learner — Faculty ratio is 24:1.

## **DIRECTIONS**

From Seattle

From 520 Eastbound, take the exit toward Lake Washington Blvd NE. Turn left onto Lake Washington Blvd NE. Turn right at NE 38th Pl. The school is the last driveway on the right before 108th. It is on the corner of NE 38th Pl and 108th across from the Park and Ride. The school is in a large red house.

From the Eastside

From 520 Westbound, take 108th Ave NE exit. Turn right at the light onto 108th Ave NE. Cross through Northup Way and immediately get into the left turn lane. Turn left onto 38th Pl (the first left after the light). Turn into the first driveway on the left. The school is in a large red house.

## **ATTENDANCE REQUIREMENTS**

Regular attendance of all classes is expected. A adult learner is expected to be prompt and to stay for the full period of the class. An absentee rate of ten percent is the maximum permitted by MACTE. Instructors are responsible for maintaining attendance records. Adult learners whose absentee rate exceeds ten percent must make up classes missed the following year. When absent, an adult learner is required to acquire the notes on the materials or work missed. Some topics covered in the course take place on one or two class days (Geography, Botany, Zoology, Science Experiments, Earth Science, Art History). Attendance is mandatory for these classes. If adult learner misses one of these classes, they must attend the classes the following year and their credential will be delayed until all course work is complete. Attendance records will indicate all absences, tardiness, or early departures.

## **COURSE COMPLETION STANDARDS**

Adult learners must complete assignments on or before the due date. Written assignments will be accepted prior to each class. Late work is not given credit. Work is evaluated as Complete or Incomplete. Course notes will not be given to adult learners who do not maintain acceptable standards of progress and financial requirements as evaluated by the Director.

## **ADULT LEARNER SERVICES**

## **ADULT LEARNER CONDUCT CODE**

Any applicant must agree to the Adult learner Conduct Code prior to admission. Violations of this code will make the violator liable for reprimand, probation, suspension, or dismissal depending upon the seriousness of the violation. The CMSTE Director will make all decisions on conduct violations.

### **Dismissal Policies and Procedures**

An adult learner who fails to maintain satisfactory progress, violates safety regulations, interferes with other adult learners' work, is boisterous, vulgar, or obscene, under the influence of alcohol or drugs during their Practicum or in class, or does not meet financial obligations to CMSTE is subject to immediate dismissal.

Smoking is NOT permitted on school campuses.

Alcoholic beverages, narcotics, or illegal drugs are not permitted on Chestnut Montessori School property under any circumstances. Proven possession is grounds for immediate dismissal.

Objectionable behavior of any kind will be recorded by date and discussed with the adult learner before any disciplinary action is taken.

Definition of terms:

1. Reprimand - Verbal warning which implies that further violations will result in probation, suspension, or dismissal.
2. Probation - Written warning, involving designated period of time implying that further violations during such time period will result in suspension or dismissal. The adult learner must abide by any specific stipulations prescribed by the probationary action.
3. Suspension - The immediate withdrawal of the adult learner from CMSTE. Suspension notification will be in writing and will include a date, after which the adult learner may apply for re-admittance. The adult learner may be re-admitted at such time as an opening exists.

4. Dismissal - The immediate withdrawal of the adult learner from CMSTE Dismissal will be in writing and will indicate that the adult learner will not be considered for re-admission. A dismissed adult learner will receive a refund in accordance with the refund policy.

**Arbitration procedure for grievances:**

A complaint not resolved after an initial verbal contact should then be stated in writing. Once a complaint is submitted to the Director of Chestnut Montessori School Teacher Education, an arbitration committee is appointed by the course. The committee consists of the Course Director, a staff member, an adult learner representative, and a practicum site administrator.

If a grievance is unresolved by the above method, adult learners may contact the American Montessori Society or the Workforce Training and Education Coordinating Board or MACTE with concerns or complaints.

## TUITION REFUND POLICY

### **CANCELLATION AND REFUND POLICY FOR RESIDENT TRAINING PROGRAMS:**

1. CMSTE must refund all money paid if the applicant is not accepted. This includes instances where a starting class is canceled by the school.
2. CMSTE must refund all money (excluding book and supply fees) paid if the applicant cancels within five business days (excluding Sundays and holidays) after the day the contract is signed or an initial payment is made, as long as the applicant has not begun training.
3. The school may retain an established registration fee equal to ten percent of the total tuition cost, or one hundred dollars, whichever is less, if the applicant cancels past the fifth business day after signing the contract or making an initial payment. A registration fee is any fee charged by a school to process adult learner applications and establish an adult learner record system.
4. If the adult learner withdraws from the class after classes have begun, the adult learner is financially obligated to the school according to the following formulas or maximum charges: (instructional time refers to academic contact hours)
  - (a) If the adult learner withdraws from class during the first week or 10 percent of contracted instructional time, whichever is less, CMSTE may retain 10 percent of tuition cost, plus all registration, other fees, AMS/MACTE adult learner fees, book and supply fees.
  - (b) If the adult learner withdraws from class after the first week or 10 percent of contracted instructional time, whichever is less, but prior to completion of 25 percent of contracted instructional time, CMSTE may retain 25 percent of the tuition cost, plus all registration, other fees, AMS/MACTE Adult learner Fees, book and supply fees.
  - (c) If the adult learner withdraws from class after completion of 25 percent and up to and including 50 percent of contracted instructional time, CMSTE may retain 50 percent of tuition cost, plus all registration, other fees, AMS/MACTE Adult learner Fees, book and supply fees.
  - (d) If the adult learner withdraws from class after completion of more than 50 percent of contracted instructional time, CMSTE may retain the full tuition cost, plus all registration, other fees, AMS/MACTE Adult learner Fees, book and supply fees.
5. When calculating refunds, the official date of an adult learner's dismissal/withdrawal occurs:
  1. When CMSTE receives notice of the adult learner's intention to withdraw the training program; or,
  2. When the adult learner is dismissed for a violation of a published school policy which provides for dismissal; or,
  3. When an adult learner, without notice, fails to attend classes for thirty calendar days.
6. All refunds must be paid within thirty calendar days of the adult learner's official dismissal/withdrawal date.
